



## Release Agreement for Placer Land Trust Activities Public Event Use

I hereby acknowledge my attendance at a Placer Land Trust (PLT) event on the private property of PLT, and/or my participation performing volunteer efforts on behalf of PLT, including but not limited to, office and special event assistance, tabling at community events, and other preserve-based efforts.

I am participating in this PLT event at my own risk. I agree to release PLT, its employees, and representatives (including volunteer docents) from liability and hold PLT harmless in regard to any and all claims, liabilities, suits, or expenses (hereafter collectively 'claim' or 'claims'), including claims caused or alleged to be caused by the negligence of PLT (but not its gross negligence or intentional or reckless misconduct), for any injury, damage, death or other loss to me in any way connected with my participation in PLT activities, entry on PLT property, or my use of PLT equipment or facilities. This release of liability applies to my successors in interest and any assigns.

If I am invited by PLT to drive my personal vehicle onto the PLT property, I do so at my own risk. I agree to have a valid driver's license in my possession, proof of insurance, and to release PLT from any liability or damage related to the use of my vehicle while on PLT property.

I agree to abide by all Placer Land Trust protocol concerning public health, and specifically those in place related to Covid-19. Additional field-based protocol will be provided under separate cover if applicable. General protocol applicable to all participants in any Placer Land Trust activity includes:

- Stay home if have a cough, fever, or feel unwell
- Wash hands thoroughly with soap and water immediately before departing for PLT activity
- Maintain 6' of distance from others
- Wear a face covering when not able to maintain social distance
